Bids will be opened publicly immediately thereafter.

Bidders shall be responsible to submit Proposals based on all information available. Proposals submitted based upon incomplete documents are done so at the risk of the Bidder.

Bids Proposals will be accepted for a Single Prime General Contractor (for Design Build Services for Shipping Container Structures and Modifications, Plumbing, H.V.A.C., Electrical, and Structural work and engineering) on a lump sum basis.

Each bidder will be required to submit with his bid, a Bid Guarantee and Contract Bond in the amount of one hundred (100%) percent of the bid in conformance with Section 153.54 of the Ohio Revised Code, or a Certified Check, Cashier’s Check or Letter of Credit in the amount of ten (10%) percent of the total bid in accordance with Chapter 153.05 of the Ohio Revised Code.

Attention is called to the fact that employees and applicants for employment are not discriminated against because of their race, color, creed, sex, or national origin as provided in RC 153.59.

Attention is also called to the fact that the project is tax exempt.

The right is reserved by the Board of Education to reject any or all bids and to waive any informalities. No bid may be withdrawn for at least (60) sixty days after the opening thereof.
