WHEREAS, James Hungerford was hired at the start of the 2018-2019 school year under a one year limited contract of employment to substitute for a regular Spanish teacher on a leave of absence; and

WHEREAS, the regular Spanish teacher for whom Mr. Hungerford had been substituting has returned to active duty from her leave of absence; and,

WHEREAS, the Superintendent has had discussions with the President of the McDonald Education Association ("MEA") regarding the suspension of Mr. Hungerford's contract of employment as part of a mid-year reduction in force due to the return to active duty of the regular Spanish teacher from her leave of absence; and,

WHEREAS, Article IX of the Negotiated Agreement between the Board of Education and the MEA and R.C. 3319.17 permit for a reduction in force of teaching personnel by reason of the return to active duty of a regular teacher following a leave of absence.

#### NOW, THEREFORE, BE IT RESOLVED:

Section 1. Based upon the provisions of R.C. 3319.17 and Article IX of the Negotiated Agreement between the Board of Education and the MEA, the Board hereby suspends the teaching contract of James Hungerford as part of a reduction in force due to the return to active duty of the regular Spanish teacher from a leave of absence, effective March 8, 2019. The Treasurer is directed to provide Mr. Hungerford with written notice of this action on behalf of the Board of Education.
